6. Pursuant to §48.161 and §48.171, Fla.Stat., the Petitioner shall also serve the Respondent by and through the Secretary of State of Florida.


7. Petitioner shall also serve the Respondent by publication by publishing the initial pleadings and orders online and provide the URL to this court.
